

Livingston Township Minutes February 22,2021

The regular meeting of the Livingston Township Board was called to order at 6:30 P.M. on February 22, 2021, and conducted by the Open Meetings Act #267, with the Pledge of Allegiance. Roll call was taken, all board members present via zoom. No guests appeared on the zoom call as ordered by MDHHS and as amended by Public Act SB 1246, which allows virtual meetings to be held for any reason through March 30, 2021, and following the Resolution 03-23-2020-04, Establishing Procedures to Allow Telephonic Attendance by Livingston Township Board Members and Members of the Public at meetings due to the Coronavirus Pandemic remains in effect. The township met via Zoom under the Michigan Department of Health and Human Services [epidemic order](#) released February 4, 2021, Which states “All indoor meetings of a public nature, all township meetings must remain virtual until March 26, 2021. It was moved by Carlson and supported by Brecheisen, to accept the consent agenda and pay bills in the amount of \$16,377.93. The hall will be closed to the public until March 15, 2021 to finish renovations. It was moved by Dipzinski and Supported by Prusakiewicz to adopt the Resolution to Establish Township Officers Salary’s. Resolution no. 02-22-21-01; to pay the Supervisor \$17,468.80, for the budget year 2021-2022 beginning April 1,2021. Roll call was taken, all in favor, resolution adopted. It was moved by Carlson and supported by Prusakiewicz to Adopt the Resolution no. 02-22-21-02 for the Clerk’s salary in the amount of \$22,927.80 for the budget year 2021-2022 beginning April 1, 2021. Roll call taken, all in favor, resolution adopted. It was moved by Brecheisen and supported by Carlson to adopt the Resolution no. 02-22-21-03, Treasurer’s salary in the amount of \$21,290.01 for the 2021-2022 budget year beginning April 1, 2021, Roll call taken, all in favor, resolution adopted. It was moved by Brecheisen and supported by Prusakiewicz to adopt the Resolution no. 02-22-21-04, Trustees’ salary in the amount of \$9,497.60; or \$4,748.80 for each trustee, for the 2021-2022 budget year beginning April 1, 2021. Roll call taken, all in favor Resolution adopted. It was moved by Mench and supported by Brecheisen to adopt the Otsego County Fire Board Budget to include the amount of \$52,250.00 for fire services in Livingston Township’s budget for the 2021-2022 budget year, roll call taken all in favor. Motion passed. It was moved by Mench and supported by Prusakiewicz, to adopt the amended Otsego County Interlocal Agreement for County Designated Assessor. Roll call taken all in favor, Motion adopted. It was moved by Prusakiewicz and supported by Mench to move our regular board meeting from March 22, 2021 to March 29, 2021, and hold the budget hearing at 6:30 p.m. Roll call taken all in favor, motion adopted. The meeting will be held at the hall with social distancing in place, providing the order to resume public meetings in person is in effect. The Meeting date and time will be posted at the hall and on the township website with instructions to meet virtually if the order is extended. Meeting adjourned at 6:53 p.m.
